PREPARATION SHEET - NOTIFICATION OF BEDBUG SERVICE

Dear Tenant

We have been hired to provide a program for bedbug control in your apartment/condominium building.

To make this program a success, we have several procedures that should be followed. They are listed below:

- All units should be inspected. If you are not going to be home on the day we are scheduled to be in your building, please make arrangements to have a key left with the manager, landlord or a neighbor. This assures you and you neighbor of a thorough and complete inspection/service.
- Please make perimeters of all rooms accessible for inspection.
- Remove all bedding from bed (blankets, sheets, pillow cases, etc.) and place in a large plastic bag. Launder the bedding the same day as the bed bug treatment.
- Remove all curtains from windows. Launder the curtains the same day as the bedbug treatment.
- Bag ALL clothes. Launder the clothes the same day as the bedbug treatment or AFTER, not before. DO NOT put clothes back in drawers until service completed.
- Remove all items under the bed and put into plastic bags or sealed containers.
- Have as much of the floor space accessible as possible
- Empty dresser drawers. Basically remove EVERYTHING from the bedrooms except the furniture.
- Take all personal items off of the dressers, night stands, floors and bag.
- Remove all miscellaneous items from dressers, night stands, chests, etc. and put into plastic bags or sealed containers. None of these items should remain in the bedroom.
- Empty closets and put into plastic bags or sealed containers.
- All large pieces of furniture must be pulled at least 2 feet away from the baseboards in every room of your home.
- Vacuum the floor, bed, bed frame, baseboards, and all the upholstered furniture.
- Everyone including pets MUST vacate the residence during service and 4 hours after service is complete.
