PREPARATION SHEET – NOTIFICATION OF RODENT/COCKROACH/ANT SERVICE

Dear Tenant

We have been hired to provide a program for rodent control in your apartment/condominium building.

To make this program a success, we have several procedures that should be followed. They are listed below:

- All units should be inspected. If you are not going to be home on the day we are scheduled to be in your building, please make arrangements to have a key left with the manager, landlord or a neighbor. This assures you and you neighbor of a thorough and complete inspection/service.
- Please empty out underneath cupboards, under the kitchen and bathroom sinks. This provides better access for a more thorough inspection.
- If you are experiencing a rodent/roach/ant problem, let us know. Leave a note on the kitchen counter or some conspicuous place so that we may better serve you.
- Please make perimeters of all rooms accessible for inspection. rodent/roach/ant often run along walls behind furniture and accessibility to these areas is very important to our service.
- If treatment is necessary because of rodent/roach/ant activity, only EPA registered products will be used. They will be placed in safe, appropriate areas secure from children or pets. All products are applied in accordance with labeled and manufacturer's directions and in accordance with state and local regulations.
- All services will include the placement of rodent monitors (e.g. traps, monitors, etc.)
